
Location Selection Factor	Score
Infrastructure and Accessibility accessibility to European ports and market entry points and the quality of existing transport infrastructure	
Market Access the size and depth of the surrounding catchment area in terms of population, GDP and forecast GDP growth	
Operational Costs basic operational costs including comparable labour, rental and land costs	
Labour Market Capacity size of working population and volume of unemployment	
Logistics Competence specialised workforce and logistics indices



Collaboration / Co-opetition - Opportunities

What are the practical opportunities for Collaboration in Export Supply Chains?

- Share ideas and strategies
- Share LSP research and selection process
- Sharing primary transport to markets
 - Improved rates
 - Use of double-decked trailers
 - More frequent deliveries
 - Consolidation for suppliers
- Sharing In-market warehouse
 - Single point of delivery – improved transport rates
 - Common systems
 - Opportunity for scheduling and splitting loads to optimise fill rate
- Sharing intermediate warehouse (Hub)
 - As In-market warehouse
 - Option becomes cost effective
 - More frequent deliveries
 - Lower stock
 - Improved date profile

Collaboration / Co-opetition - Issues

Issues to be Addressed

- Legality
- Sensitivity of information
- Control – how to plan collaboratively?
- Conflicting objectives
- Setting of priorities
- Allocation of costs
- Resolution of problems (delays, leaking pallets)
- Geographical challenges (Cork – Donegal)
- Consolidation centre vs multiple collection points
- Contract owner

Collaboration / Co-opetition – Alternative Strategies

Alternative Strategies

- Establish Joint Venture Company
- Use Irish Agent or Distributor, acting on behalf of a number of Irish companies
 - Consolidates in Ireland
- Use same “in market” Agent or Distributor
- Use Freight Forwarder or Transport Coordinator
- Use of Online Marketplaces
