Information Sharing

In order to facilitate the audit, you are asked to provide information in advance regarding your farming enterprise. You are asked to agree to allow DAFM, ICBF and your Milk Purchaser to provide relevant data to Bord Bia as outlined below. Some of this information will verify compliance with certain audit criteria (i.e. Herd Health Certificate, water quality test results (where available) and records of bulk tank and milking machine servicing). The remainder of this information will be used for the purpose of calculating the carbon footprint of your farm and reporting the sustainability performance of your farm back to you. Providing this information in advance will also help to reduce the length of time it takes to complete the audit on your farm.

Irish Cattle Breeding Federation (ICBF)

I hereby give permission to the Irish Cattle Breeding Federation to make available a copy of my herd's calf registration data, animal identification and movement system data (AIM), my name, address, mobile number, animal events data and other relevant cattle breeding data to Bord Bia. I understand that all such information will be stored in the Bord Bia database and will be only used for the purposes of the Sustainable Dairy Assurance Scheme calculations of carbon footprinting. I will notify Bord Bia if I wish to opt out of this arrangement in the future*.

Department of Agriculture Food and the Marine (DAFM)

I authorise the Department of Agriculture, Food and the Marine to release bovine data held on the Animal Identification and Movement (AIM) database for the herd number indicated above to Bord Bia for the purposes of participation in the Carbon Footprint programme. I will notify Bord Bia if I wish to opt out of the Carbon Footprint programme in the future*.

Milk Purchaser(s)

I authorise the Milk Purchaser(s) (to be printed overleaf) to release data on the milk supplied to the milk purchaser (volume and composition but also other info that will save audit time (herd health cert no, water test result (where available))) for the herd number indicated above to Bord Bia for the purposes of participation in the Carbon Footprint programme and to permit benchmarking the farm in conjunction with the Teagasc / Bord Bia Carbon Navigator. I will notify Bord Bia if I wish to opt out of this arrangement in the future*.
